B. RATIONAL

As for the thesis using a different assessment method. The thesis examination stages are divided into 2, namely the Proposal Seminar Examination and the Comprehensive Examination. The Proposal Seminar Exam has a weight of 33% and the Comprehensive Exam has a weight of 67% towards the final score of the Student Thesis.
